- Paperback books with covers removed (These cannot legally be sold or used by the library)
- Magazines
- Textbooks
- Records
- Computer software
- Condensed books
- Encyclopedias

These materials cannot be added to The Library collection or Friends of The Library book sales and The Library must pay to dispose of them.
